
Updates to British Columbia Ambient Water Quality Guidelines- February 2025

This table outlines recent updates to British Columbia's Ambient Water Quality Guidelines.

Date	Updated file	Description
February 2025	6PPD-Quinone Water Quality Guidelines	Aquatic life guideline was published.
August 2024	Working Water Quality guidelines	The B.C. Working Water Quality Guideline has been updated, with several new guidelines added and some existing ones modified.
July 2024	Lead Water Quality Guidelines	Aquatic life guideline was updated using the Federal Environmental Quality Guideline.
June 2024	Nickel Water Quality Guidelines	Aquatic life guidelines have been updated.
February 2024	Zinc Water Quality Guidelines	Corrected references to the previous B.C. WQG (1999) to clarify that the 1999 WQG was for total zinc (Table 7.1, Figure 9.1, and text throughout).
November 2023	Antimony Water Quality Guidelines	Aquatic life guideline was published.
August 2023	Zinc Water Quality Guidelines	Aquatic life guideline was updated using the CCME Environmental Quality Guideline.
April 2023	Aluminum Water Quality Guidelines	Aquatic life guideline was updated using the Federal Environmental Quality Guideline.
December 2021	Lead, Mercury, PCB, PAH, Chlorophenol Water Quality Guideline Overview and Technical Reports	Fish tissue guidelines for human consumption rescinded and removed due to out-of-date methods and information. Fish tissue guidelines for human consumption now based on the screening value approach as outlined in the <u>Derivation of Screening Values for Contaminants in</u> <u>Fish Tissue</u> .
September 2021	Molybdenum Water Quality Guidelines for the Protection of Freshwater Aquatic Life, Livestock, Wildlife and Irrigation	New water quality guideline developed using the most up to date science.
February 2021	Working Water Quality Guidelines	See document for all changes since 2017 version.
June 26 th , 2020	Source Drinking Water Quality Guidelines: Guideline Summary	Clarity added to introduction about application of these guidelines. Thirty-two parameters have either been updated or newly adopted as SDWQGs.
